Guidance on and Instructions for Completing the ECCC Victim Information Form

Introduction to Victim Participation

The Internal Rules of the Extraordinary Chambers (the "ECCC") provide for the participation of survivors of Democratic Kampuchea in the upcoming tribunal proceedings. Elaborating on the Internal Rules, on October 5th, 2007, the ECCC issued a Practice Direction on Victim Participation. The Practice Direction envisages the participation of survivors in three ways: (1) by volunteering to be witnesses (namely, by giving live testimony about crimes suffered or witnessed); (2) by filing complaints (namely, by providing the Co-Prosecutors with factual information to aid prosecution); and (3) by applying to become civil parties (namely, by applying to join the proceedings as a party and to claim collective or moral reparations). In addition to detailed information on participation, the Practice Direction contains a Victim Information Form (the "Form") for survivors to submit to the ECCC Victims Unit. The Practice Direction requires the Co-Prosecutors to contact every complainant informing them of their decision whether to accept or reject the complaint within 60 days of registration.

Survivors should be aware that the ECCC will select only a small number of survivors to participate in the trials. If you choose to complete the Victim Information Form and the ECCC fails to select you, this does not mean that the tribunal does believe or value the information that you have provided. The ECCC has limited resources, a short time frame, and focuses on senior Khmer Rouge leaders and those most responsible for crimes from 1975-1979. Therefore, the ECCC may not have the resources or the power to charge the person responsible for the crime against you or may only charge the responsible person in relation to crimes committed elsewhere or at another time.

Importance of Victim Participation

Although the ECCC will select only a small number of survivors to participate, it is very important that survivors complete the Victim Information Form. By completing this Form, survivors will assist the ECCC in its task of trying senior Khmer Rouge leaders. Furthermore, by contributing to the ECCC's archives, survivors will participate in the creation of a vast historical record of the crimes of the Democratic Kampuchea era. This will help improve understanding of the period and create a valuable resource for future generations.

Although DC-Cam considers the participation of victims in tribunal proceedings to be very important, survivors must decide for themselves whether they wish to complete the Form. If you have reservations about completing the Form at this time, please feel free not to do so. You may always contact DC-Cam for assistance if you wish to complete it at a later time.

Modes of Victim Participation

According to the Practice Direction, survivors may participate in the proceedings in three ways:

- By volunteering to be a witness;
- By filing a complaint; AND
- By applying to be joined as "victims" in a civil party action.

First, survivors may volunteer to be witnesses at trial. Most commonly, witnesses would give live testimony to the ECCC about crimes that they have suffered or witnessed. The ECCC will select only very few witnesses for the proceedings depending upon who can offer the most direct testimony proving the crimes charged. If a survivor is selected to be a witness, he or she would travel to the tribunal to give his or her story. If witnesses fear for their safety, the ECCC may order protective measures to protect the witness from the public, such as a pseudonym or voice and image distortion.

Second, survivors may file a complaint with the tribunal giving a description of the crime(s) witnessed or suffered. The Co-Prosecutors may, at their discretion, choose to reject the complaint, include the complaint in an ongoing preliminary investigation, conduct a new preliminary investigation or forward the complaint directly to the Co-Investigating Judges. The Co-Prosecutors must decide whether to proceed based on the complaint and inform the complainant of their decision within 60 days. Complainants should have only limited concerns relating to personal security, as all complaints remain confidential and complainants need not testify. As a complainant would not have to appear before the ECCC, all victims or witnesses of crimes during the Democratic Kampuchea period should consider filing a complaint. Complaints are a very important source of factual information for the tribunal.

Third, certain survivors may apply to become a civil party to the proceedings and to claim collective and moral reparations. Survivors may apply to be a civil party up until the beginning of trial proceedings. In order to qualify as a civil party, survivors must qualify as "victims" within legal meaning. The legal definition of "victim" requires that they have suffered a physical, material, or psychological injury; that the injury was the consequence of a crime; and that they experienced it themselves. The loss of a family member may qualify as psychological injury. As the ECCC has not as yet given any further guidance as to which survivors may qualify as "victims," all survivors interested in becoming civil parties should complete the application. If a survivor's application to become a civil party is successful, he or she will become a party to the criminal proceedings. The civil party may not be a witness. The civil party will be responsible for securing legal representation. The Victims Unit and victims' rights associations may provide assistance.

"Collective and Moral" Reparations

The Internal Rules provide that civil parties to the proceedings may claim "collective and moral" reparations. "Collective" reparations envisage reparations benefiting victims collectively or society as a whole. "Moral" reparations envisage symbolic reparations. The Internal Rules provide the following as examples of "collective and moral" reparations:

- An order to publish judgment in any appropriate news or other media at the convicted person's expense;
- An order to fund any non-profit activity or service that is intended for the benefit of Victims; or
- Other appropriate and comparable forms of reparation.

The Form provides civil party applicants with the opportunity to propose their preferred form of "collective and moral" reparations. Appropriate proposals include creating a national memorial, establishing a mental health clinic for victims, or printing commemorative banknotes.

The Role of DC-Cam

The Center plays a limited role in victim participation in tribunal proceedings. We are not a victims' right association and we will <u>not</u> provide legal representation. We seek only to *inform* survivors of their participation rights and to *assist* them in completing and filing the Form with the ECCC Victims Unit. We have considerable experience in doing so, having already assisted more than 500 survivors. Due to our established contacts with survivors of Democratic Kampuchea and possession of the Renakse Petitions, we believe that the Center has an important part to play in assisting victim participation. Where it assists survivors in filing the Form, the Center will treat the Form confidentially and deliver it promptly to the Victims Unit.

Step-by-Step Instructions for Completion

Protective Measures

If you fear for your personal safety as a result of completing this Form, you may request the ECCC to order you protective measures in the event it selects you to participate in the proceedings. Protective measures may protect you from the public through the use of, for example, a pseudonym or voice and image distortion during the proceedings. Please note that the Victim Information Form does not provide space for requesting protective measures. As such, if you wish to request such measures, please attach a request on a separate sheet of paper.
